

## CAREER PROSPECTS

The LLB (Hons) Law degree can open a variety of career pathways both locally and globally. The traditional pathways for LLB graduates include working as Attorneys-at-law of the private bar, officers of the Attorney-General's department starting out as state counsel, joining the judiciary as judges, working in government departments and ministries including the Legal Draftsman department, working in law firms, working as legal officers of private companies, including banks, joining as academics. Non-traditional career pathways include becoming legislators, working at NGOs and international organizations such as the UN, working at Legal Process Outsourcing Companies (LPOs), or becoming intellectual property rights agents or working as researchers, professional arbitrators, mediators or negotiators.

## ABOUT PROGRAMME

The 3-year degree programme consists of core modules which give students a firm grasp of fundamentals of English law, and option modules which give students an opportunity to acquire knowledge about specialized areas of law such as human rights, financial crimes, banking, international law etc. The degree with its strong industry focus offers modules such as mooting, mediation and negotiation that allow students to equip themselves with the knowledge and skills needed for traditional legal careers as well as non- traditional legal careers, especially, in the area of alternative dispute resolution.

### ENTRY REQUIREMENTS:

3 passes in any subject stream at GCE (Advanced Level) Examination (Sri Lanka) in one and the same sitting with a Credit pass for English at the GCE (Ordinary Level) examination or GCE Advanced Level (Edexcel/Cambridge) with 3 D passes in one and the same sitting and a pass at the aptitude test conducted by SLIIT and the interview conducted by the School of Law, SLIIT

## COURSE STRUCTURE:

All modules are 20 credit modules except the Dissertation module (40 credits) at L6. Students are required to obtain 120 credits in each year of study from a combination of core and option modules
