Guidelines on Submission of Research Papers

Track - Law

1. <u>Guidelines for Preparation of Research Papers</u>

- i) The research paper must represent original research undertaken by the author/s.
- ii) The title should be lucid & simple and capture the essence/spirit of the research presented.
- iii) The paper shall not exceed six pages of A4 size paper, printed on one side with 2.5 cm. margin on all four sides.
- iv) Times New Roman Font (12 pt.) should be used with 1.5 times spacing between lines and paragraphs. The beginning of the paragraph should not be indented. The text should be justified.
- v) Language should be uniform (either British or US).
- vi) The name of author/s of the paper, the name of the institution/s where the work was carried out and the email address of the author/s should be given. Author/s's initials and the first letter of the surname are to be in capital letters and others in small letters when giving the name/s.
- vii) OSCOLA guidelines are to be followed for referencing.
- viii) The paper should be free from any acts of plagiarism or copying.
- ix) The author/s should submit a declaration (Annex 1) that the research paper is that of the author/s, that the paper does not offend any rule relating to plagiarism and/or research ethics and that it has not be published or presented in or submitted for publication or presentation to, any other place.
- x) The author/s may nominate up to five reviewers, competent of reviewing the paper, and include their affiliations, email addresses and phone numbers
- xi) It should be submitted electronically to <u>sicash.fhs@sliit.lk</u>
- xii) The due date for submission is 30 June 2020.

2. Format for Preparation of Research Papers

The following format is prescribed for the preparation & submission of paper:

- ▶ Title
- Abstract (200 words)
- Background

- Justification/Objective
- Research Design: research problem; hypothesis; questions; methods; theoretical framework; materials
- Analysis, findings
- Conclusions & recommendations
- References
